We are pleased to inform you that Conemaugh Valley School District will be continuing the Community Eligibility Provision (CEP) in the 2018-2019 school year. This program is available to schools/districts who are participating in the National School Lunch and School Breakfast Programs.

All enrolled students of Conemaugh Valley School District are eligible to receive a nutritional breakfast and lunch every day at the school at **no charge** to your household.

No further action is required of you. Your child(ren) will be able to participate in these meal programs without paying a fee or submitting an application.

Please note that if you owe for any previous balance, you will still be expected to pay that debt. NO students will be allowed to charge any items to their account unless they have the money to cover the cost of the items in their account.
