(ACT 34) PA STATE CRIMINAL HISTORY RECORD FORM

⇒ Valid for five years after issuance.

(ACT 151) PA CHILD ABUSE HISTORY CLEARANCE

⇒ Forms available at school offices and the Department of Human Services

⇒ **Fee \$13.00** – Money Order Only – payable to "PA Department of Human Services". For volunteer purposes, you may obtain this clearance free of charge once every 57 months.

Clearances, cont'd

(ACT 114) FINGERPRINT CLEARANCE FOR EMPLOYEES ONLY

- ⇒ Finger-print based multiple-step background check.
- ⇒ Applicant must register online to be fingerprinted – (<https://uenroll.identogo.com>) or contact IDEMIA by telephone at 1-844-321-2101.
- ⇒ Fee is \$25.25 for employees, payable at time of registration by credit or debit card. Use the following service codes to register: Employees over 14 yrs old that will have contact with children – IKG6XN. Click on Schedule or Manage Appointment. Complete all necessary information. This will be through the PA Department of Education (NOT Dept of Health & Human Services).
- ⇒ Applicants will need to print a copy of their registration receipt. You will then proceed to a fingerprint site where qualified State or Federal photo ID is reviewed. (Locations and approved ID types can be found at www.uenroll.IdentoGO.com) Scanned fingerprints are electronically submitted to state police where they will then be submitted to the FBI as required.
- ⇒ Valid for five years after issuance.

(ACT 114) FINGERPRINT CLEARANCE FOR VOLUNTEERS ONLY

- ⇒ Finger-print based multiple-step background check.
- ⇒ Applicant must register online to be fingerprinted – (<https://uenroll.identogo.com>) or contact IDEMIA by telephone at 1-844-321-2101.
- ⇒ Fee is \$23.25 for volunteers, payable at time of registration by credit or debit card. Use the following service codes to register: For Volunteers only-IKG6ZJ; Click on Schedule or Manage Appointment. Complete all necessary information. This will be through the PA Department of Health & Human Services (NOT the PA Dept of Education).
- ⇒ Applicants will need to print a copy of their registration receipt. You will then proceed to a fingerprint site where qualified State or Federal photo ID is reviewed. (Locations and approved ID types can be found at www.uenroll.IdentoGO.com) Scanned fingerprints are electronically submitted to state police where they will then be submitted to the FBI as required.
